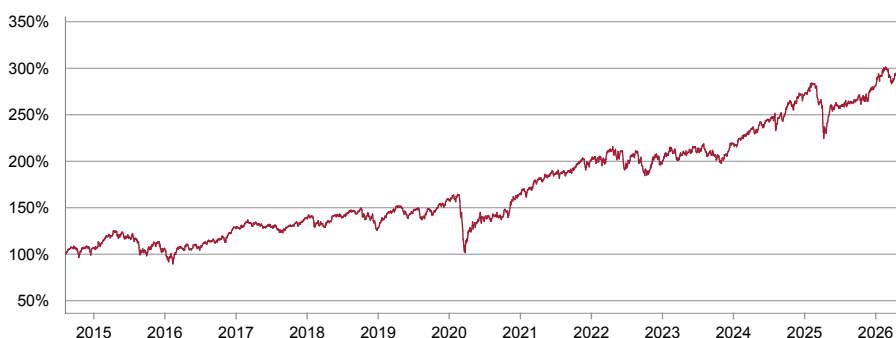
## Investment suitability
