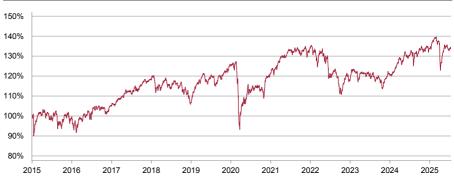
Investment suitability
